Introduction

Trade balance

South Africa's trade (i.e. exports plus imports) with the rest of the world increased by 2.7% in nominal rand value terms in 2015 compared to 2014, driven mainly by expanding trade with the European Union (EU) (8.7% growth), Asia (5.4%) and the North American Free Trade Agreement (NAFTA) (9.1%) regions.

The trade deficit narrowed by R42.5 billion to reach R78.7 billion for 2015 as the growth in exports (5%) outpaced that of imports (0.5%) over the period. The continuing depreciation of the Rand through 2015, which failed to translate into significant benefits for South Africa's export performance, was a further contributing factor in the country's persistent trade deficit.

Exports

South Africa's merchandise exports grew by 5% to R1.01 trillion in 2015 on the back of rising exports to: the EU (R27.6 billion increase) - mainly to Germany, the United Kingdom, Italy, Belgium and Spain; and NAFTA (R7.1 billion increase) - mainly to the United States. Export growth in 2015 was supported by manufactured exports, which increased by R25.6 billion, followed by exports of the mining (R8.3 billion) and agriculture, forestry and fishing sectors (R4.2 billion).

Manufacturing export growth, at 6.0% in 2015 to R610.9 billion, was largely driven by exports of passenger vehicles (except buses), jewelry and related products such as coins, as well as basic non-ferrous metal products such as copper and nickel. These categories collectively accounted for 14% of overall manufactured exports value in 2015, with passenger vehicles alone contributing 11.5% of that total.

Mining exports increased by 2.4% (or R34.5 billion) in 2015 compared to 2014, mainly influenced by higher exports of platinum, gold, chromium and precious metal ores. This was despite declining export values of iron ore, manganese, copper and coal.

The 8.5% growth in the exports of the agriculture, forestry and fishing sector over the year to R41.8 billion was driven by increased exports of citrus fruit, nuts, grapes, apples, as well as pears and quinces.

<u>Imports</u>

Imports into South Africa from the rest of the world grew marginally, by 0.6% to R1.09 trillion, in 2015, driven mainly by increased imports from Asia (largely China, Vietnam, India, Hong Kong, and Taiwan) and the EU (mainly Germany and Belgium).



Manufactured imports increased by 9.5% to R947.9 billion in 2015, with most of the growth coming from higher imports of electric apparatus for line telephony; original equipment components; passenger vehicles (except buses); electrically-powered rail locomotives; electric motors and generators; as well as computers. Together these categories contributed 22.9% of import demand for manufactured products from the outside world.

Mining imports declined by 41.3% to R114.4 billion in 2015, with crude oil, platinum and diamonds as the major contributors to this decline. The oil import bill plunged by R78 billion to R101.7 billion in 2015. This was despite substantial increases in imports of nickel, titanium, natural magnesium carbonate, magnesium oxide and quartz.

Imports of agriculture, forestry and fishing products grew by 23% to R21.8 billion in 2015, with most of this growth attributable to higher imports of maize, wheat and meslin, live bovine animals, coffee, as well as live sheep and goats. These five categories contributed about 49.5% of the total imports of agriculture, forestry and fishing products in 2015.
